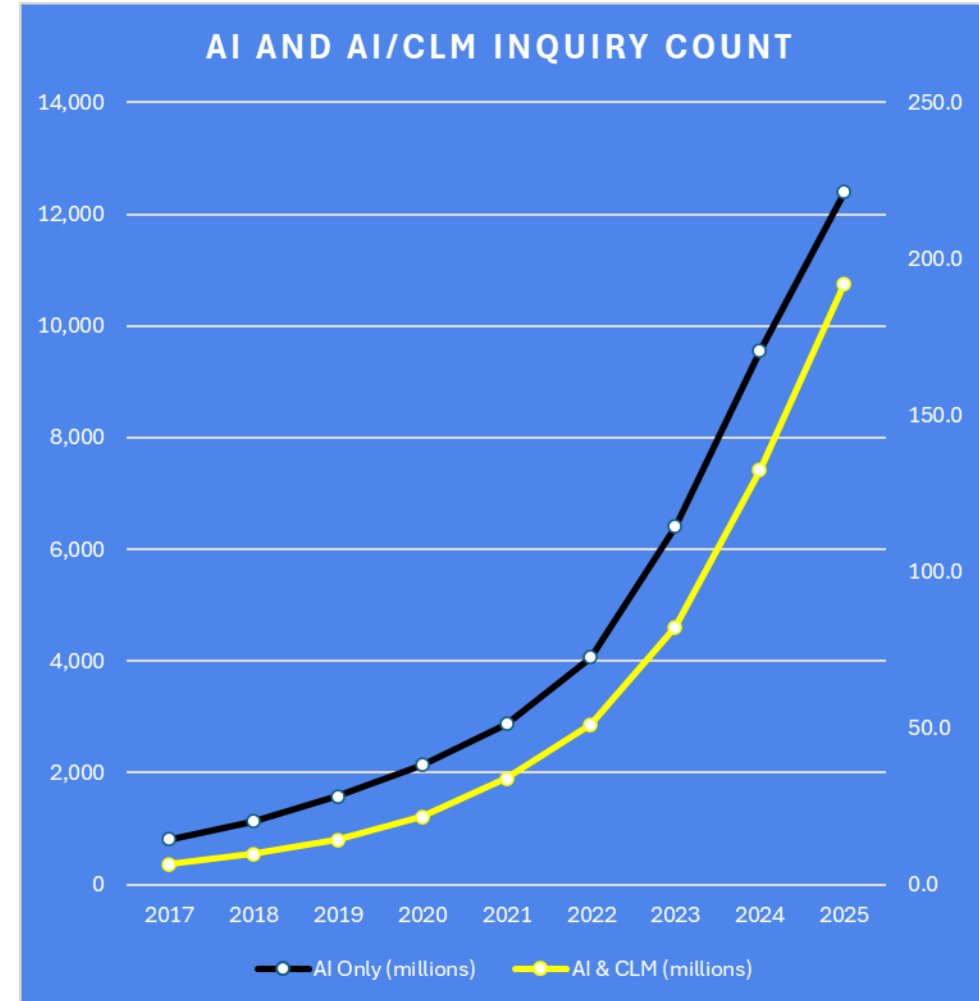

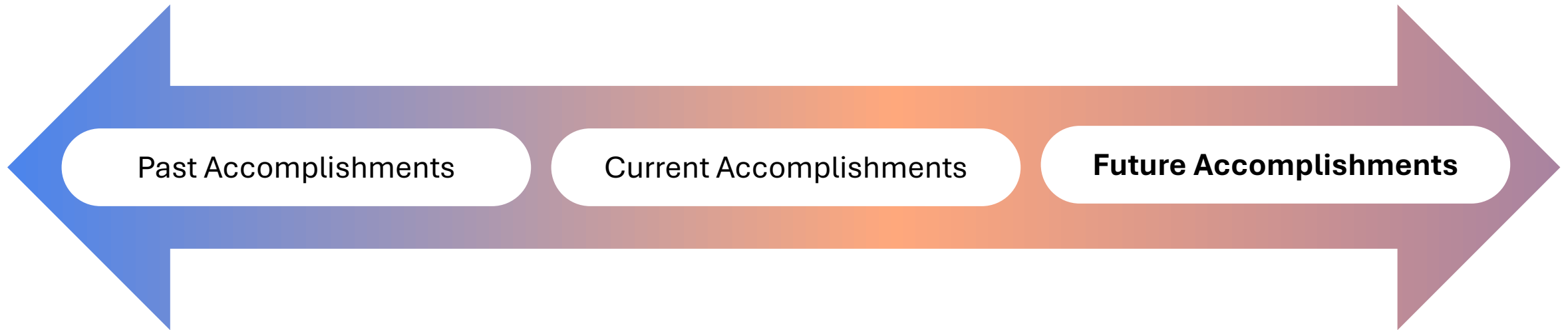

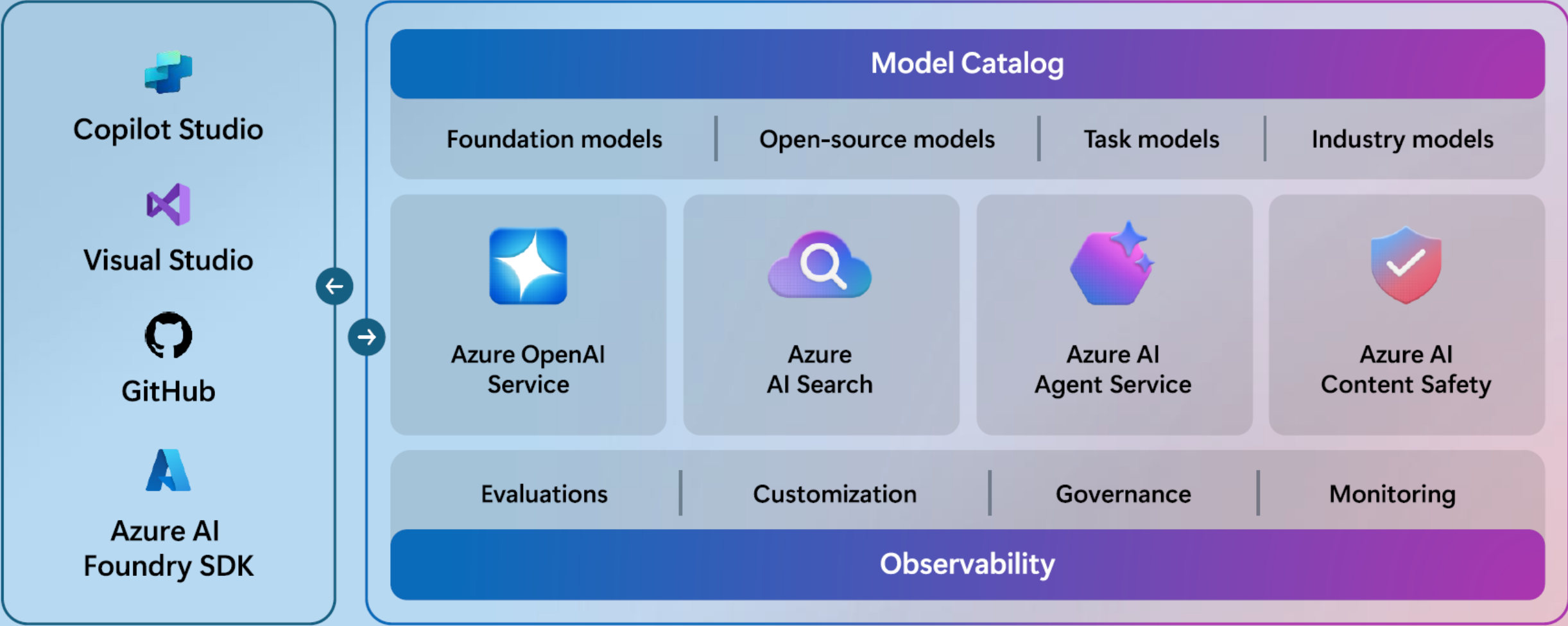

Azure AI Foundry Service

Microsoft's AI Foundry Service, (formerly, Azure AI Studio) serves as an underlying developer platform for designing, customizing and managing AI applications.

Practical Implications

A/The most robust and secured AI platform for building out AI-based applications which can be used for contract processing optimization.

Model Context Protocol

Microsoft is no longer constrained to its or OpenAI's AI models. Through Microsoft, the top AI models from Microsoft & 3rd parties (Anthropic, DeepMind, Google, Hugging Face, Meta, Xai etc.) can be securely accessed.

Practical Implications

The right model can be selectively employed through Microsoft to address specific contract management objectives.

Agent-to-Agent (A2A)

Through Microsoft Foundry, A2A allows for diverse "Agents" to be configured to communicate with each other and to do so autonomously. This can happen within an organization or across platforms.

Practical Implications

You can configure Agents to communicate with each other, from data exchanges to taking automated actions via the respective Agents.

Highlights From 2025 Microsoft Build

Copilot Tuning

Copilot tuning allows for non-technical users to refine the AI Models and their usage patterns to fully leverage your organization's enterprise data, and it does so in a secured and fully integrated capacity.

Practical Implications

Heightened specificity can be simply applied when using Copilot for analyzing and taking action against your organization's contract documents and data.

Discovery/Researcher

AI-powered agentic platform that performs extensive and deep analysis for complex problem solving and decision making across enterprise content/domains. It will automate reasoning, simulate outcomes and dynamically generate insights.

Practical Implications

Your contracts and data across diverse sources can be searched upon in much more in-depth capacities to gain key insights and with the ability to take action.

NLWeb

The NLWeb is a protocol/toolkit introduced by Microsoft to incorporate websites to support natural language interfaces via AI. This allows for more intuitive user interactions when accessing web sites.

Practical Implications

NLWeb can allow for a more intuitive and natural search experience when accessing information on websites.

Extract metadata with simplified visualization & data placement

Compare 3rd party agreement against playbook, gen AI to provide guidance and new language

Clause Extraction

Clause extraction for variant analysis, memorialization & processing

4

Obligation Extraction

Obligation extraction with standard attribution, jeopardy management and reporting

5

Contract Summarization

Generate document or metadata-based summaries for workflow review and execs

6

Contract Language Translation

Translate & save documents into alternative languages with auto-detection

7

Agents & Automation

Next gen AI-based search for private and public repositories & process automation

8

AI-Influenced Workflow

Dynamically detect workflow patterns and adjust approval processes accordingly

9

Contract & Clause Generation

“MS Copilot” Generative AI coupled with Appropriate security, IP and ethics protections

Practical Considerations For AI & CLM

1 Field Validation

When raw text is AI-Processed, such as a counterparty name and address, the data must be validated against counterparty lists, state/province lists, country lists & more.

2 Date Format Transformation & Validation

AI-Processed date information (spelled out, formatted differently) needs to be transformed into an actual date field & then validated to ensure that the date is accurately stored.

3 Currency Value Format & Validation

Like “date” information, values can be spelled out and formatted differently and these need to be transformed and then validated to achieve a higher level of accuracy.

4 Dynamic Creation Of New Values

When a new AI-Processed value (e.g. new counterparty), the extracted information can automatically populate the validation lists which can influence workflow and other downstream activities.

Practical Considerations For AI & CLM

5 Confidence Levels

As data is AI-Processed, an indicator should be made available to indicate the confidence level of the extraction. Through “suggestions”, users can easily discern.

7 Hierarchical Data Mapping & Placement

AI-Processed data will be placed into the appropriate hierarchical location. For example, a new counterparty will be added in the counterparty list and Contract Type, Effective Date, Amount will be placed into the Contract Record.

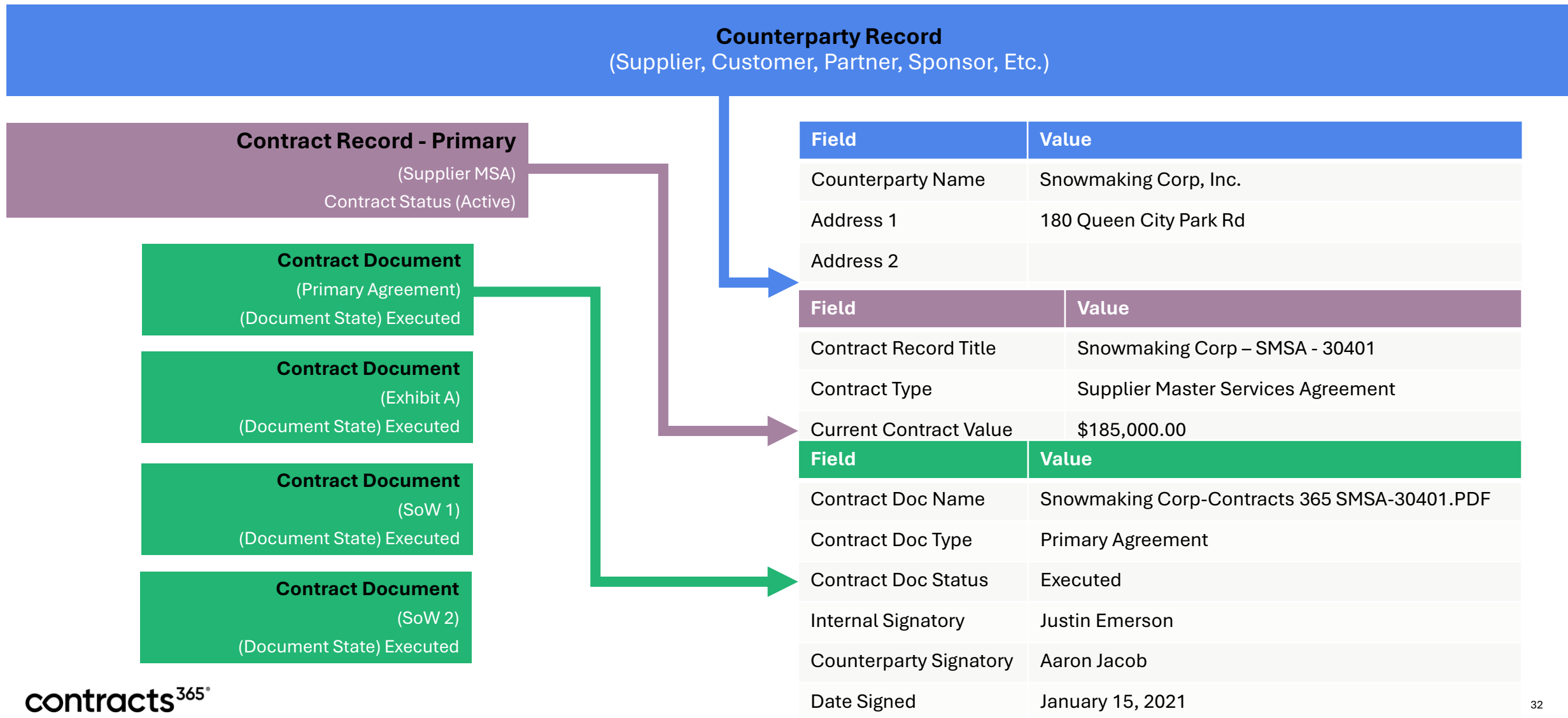
6 Real-Time Document Access & Highlighting

Users should be able to easily see the source document / content and be taken to immediately to that location for verification and/or action.

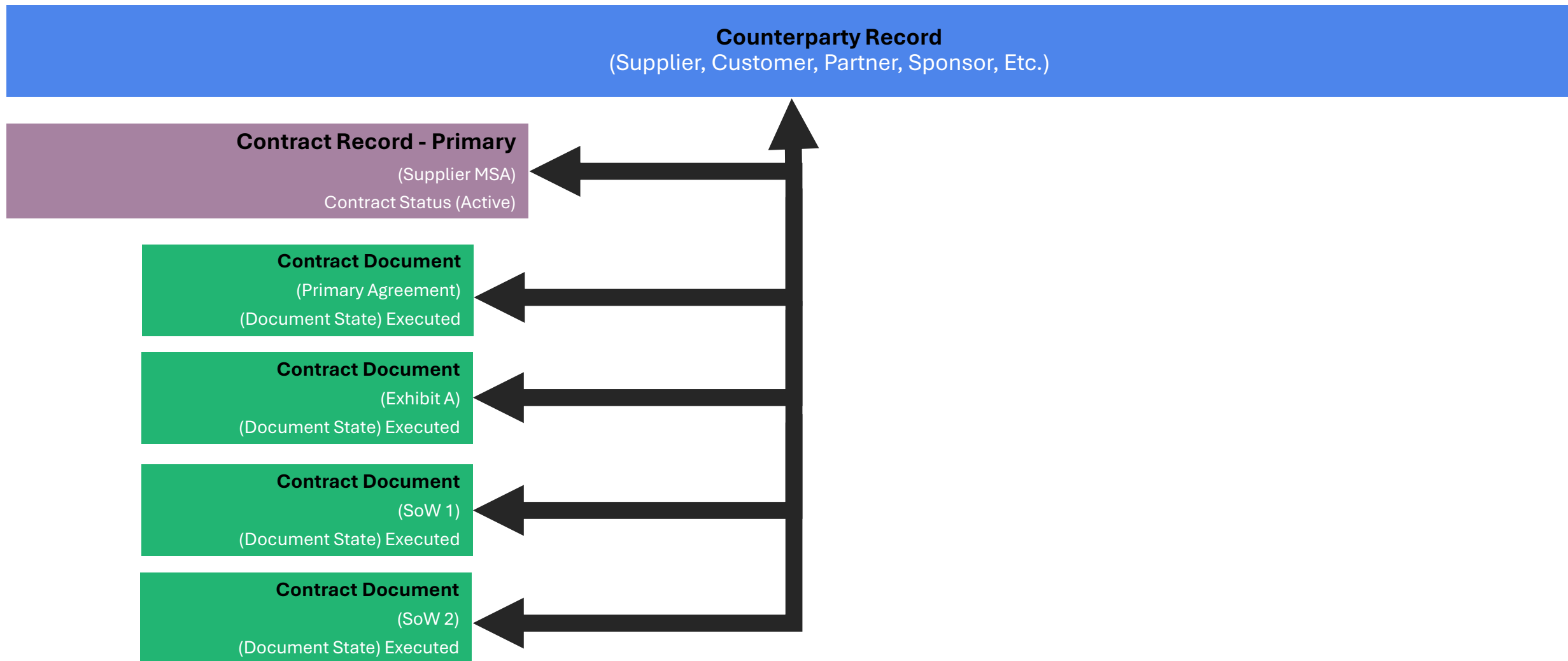
8 Automated Relationship Binding

Once AI-Processed data is written into the correct locations of the hierarchy, the data is then bound together to allow for the necessary and simplified linking experience. This allows users to see actual documents related to contract records which are in turn, related to counterparties.

Get Your Hands Dirty

The only way to become comfortable with AI is to start using it for a focused purpose.

Prepare

Using AI requires a level of commitment and iterative efforts

Set Expectations

Do not over-promise or scare users so much that they don't want to use AI

On-Going Commit

AI is not going away and one must commit to exploring new AI (and non-AI) reasons

Key Steps

- Pick 1-2 use cases that you are looking to solve
- Be Patient and plan to experiment

Key Steps

- Prioritize high-value items with "Time to Value"
- Measure key before and after metrics

Key Steps

- Secure champions who will support initiatives
- Openly ask for feedback

Key Steps

- Meet regularly with suppliers
- Perform short-term (1-2 week) trials
- Get team round up

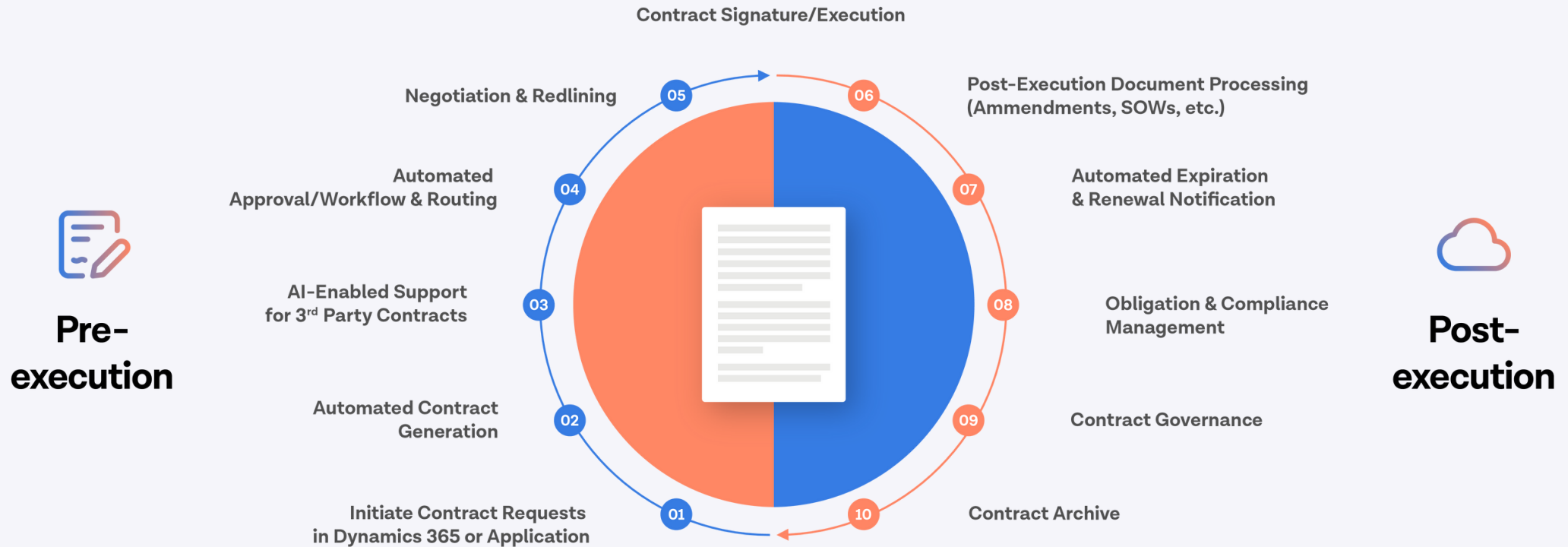

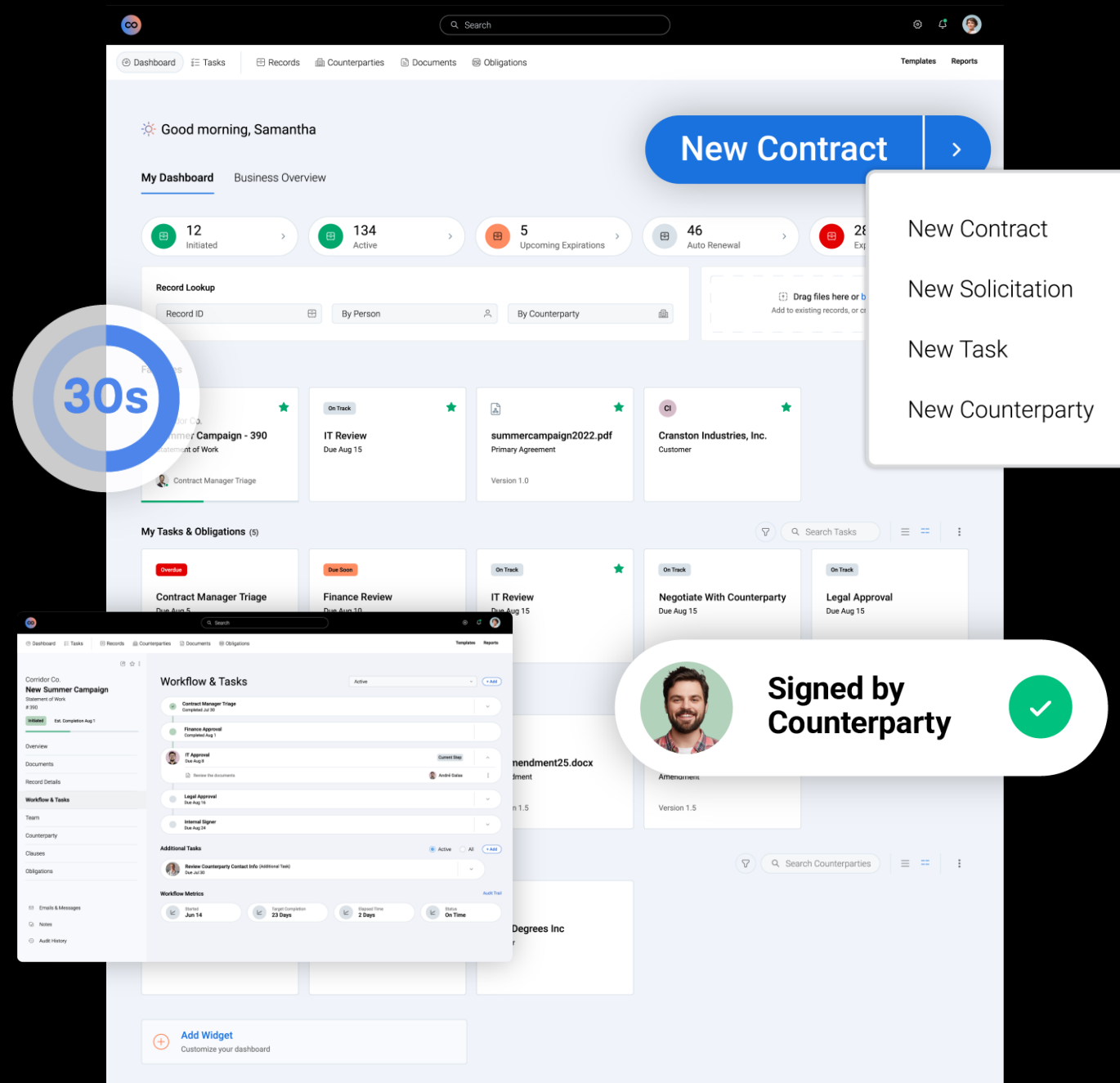
